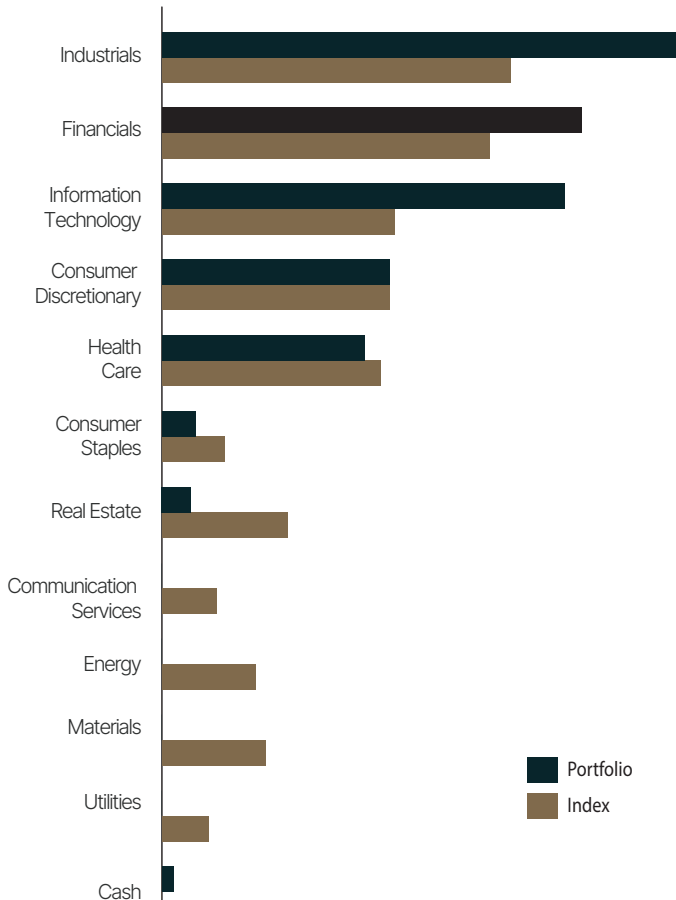

DEFINITIONS

Standard Deviation	The square root of the variance. A measure of dispersion of a set of data from its mean.
Beta	A measure of the volatility—or systematic risk—of a security or portfolio compared to the market as a whole (usually the S&P 500). Stocks with betas higher than 1.0 can be interpreted as more volatile than the S&P 500.
Correlation	Statistical measure of the degree to which the movements of two variables (stock/option/convertible prices or returns) are related.
Tracking Error	In an indexing strategy, the standard deviation of the difference between the performance of the benchmark and the replicating portfolio.
Up Capture	The up-market capture ratio is calculated by dividing the manager's returns by the returns of the index during the up-market and multiplying that factor by 100.
Down Capture	The down market capture ratio is calculated by dividing the manager's returns by the returns of the index during the down-market and multiplying that factor by 100.
Batting Average	The term batting average refers to a statistical technique used to measure an investment manager's ability to meet or beat an index. The higher the batting average, the better. The highest number possible average would be 100% while the lowest is 0%.
Information Ratio	The ratio of annualized expected residual return to residual risk. A central measurement for active management, value added is proportional to the square of the information ratio.
Return on Equity	Indicator of profitability. Determined by dividing net income for the past 12 months by common stockholder equity (adjusted for stock splits). Result is shown as a percentage. Investors use ROE as a measure of how a company is using its money. ROE may be decomposed into return on assets YROAX multiplied by financial leverage (total assets/total equity).
Price/Earnings Ratio	Current stock price divided by trailing annual earnings per share or expected annual earnings per share. Assume XYZ Co. sells for \$25.50 per share and has earned \$2.55 per share this year; \$25.50 [10 times \$2.55. XYZ stock sells for ten times earnings.
Dividend Yield	Indicated yield represents annual dividends divided by current stock price.
Active Share	Active Share tracks the disparity between a portfolio manager's holdings and that of its benchmark index. Active Share is calculated by taking the sum of the absolute value of the differences of the weight of each holding in the manager's portfolio and the weight of each holding in the benchmark index and dividing by two.
Alpha	A measure of the active return on an investment, the performance of that investment compared with a suitable market index.
