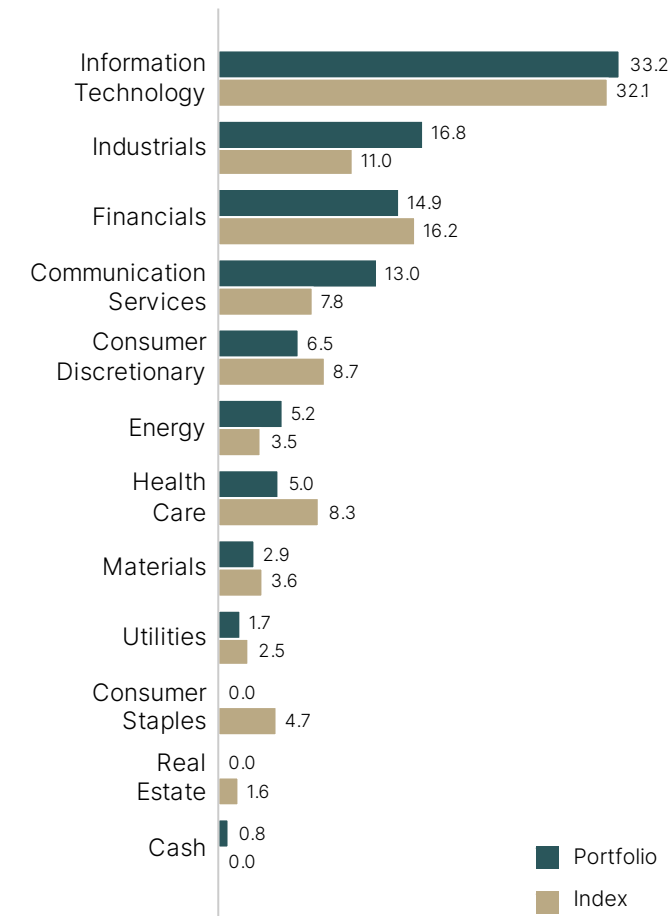

| <b>Standard Deviation</b>   | The square root of the variance. | <b>Return on Equity</b>     | Indicator of profitability. Determined by dividing net income for the past 12 months by common stockholder equity (adjusted for stock splits). Result is shown as a percentage. Investors use ROE as a measure of how a company is using its money. ROE may be decomposed into return on assets YROAX multiplied by financial leverage (total assets/total equity). |
| <b>Price/Earnings Ratio</b> | Current stock price divided by trailing annual earnings per share or expected annual earnings per share. Assume XYZ Co. sells for \$25.50 per share and has earned \$2.55 per share this year; \$25.50 [ 10 times \$2.55. | <b>Active Share</b>         | Active Share tracks the disparity between a portfolio manager's holdings and that of its benchmark index. Active Share is calculated by taking the sum of the absolute value of the differences of the weight of each holding in the manager's portfolio and the weight of each holding in the benchmark index and dividing by two.                                 |
